Subject: Third Edition of CAN/ULC-S525-07, Audible Signal Devices for Fire Alarm Systems, Including Accessories

This is further to our Standards Bulletin 2007-08, dated March 15, 2007, announcing the third edition of the Standard for **Audible Signal Devices for Fire Alarm Systems, Including Accessories**.

As indicated in the March Bulletin, Underwriters' Laboratories of Canada has adopted provisions of the Edition of the Standard. All new submittals of **Audible Signal Devices for Fire Alarm Systems, Including Accessories** will be investigated in accordance with these requirements. We expect all existing listings to comply with the new requirements by September 30, 2009. Underwriters' Laboratories of Canada is reviewing all currently listed products and is requiring a manufacturing facility audit and product examination to verify compliance with the construction requirements of this Edition of the Standard.

Sometimes, customers may not choose to continue manufacturing their ULC-certified product after new/revised requirements go into effect. Focusing our file review efforts on only those products that will continue to be ULC certified is one way to reduce your file review costs. To ensure that we're aware of your plans, please provide the information requested in the List of Product Information form for your specific review no later than November 30, 2007. We will omit from the file review all products included on the List of Product Information form, and after the effective date, these products will no longer be considered ULC certified. Please include your authorization to terminate your ULC certification for the noted products as well as the date you wish the termination to go into effect

To assist in complying with these requirements, a Summary of Requirements has been created. This list, which will form the basis of the review and product examination, and the Standards Bulletin 2007-08, are enclosed for your reference.
