- Sets minimum requirements for alarm service companies competing for your business; resulting in consistent and realistic bids for services required by your local Fire Marshal.

 with those false alarms such as service fees
 from the alarm company, fines from the
 fire department, and the cost of your staff
 responding for false alarm calls outside of

- The program requires alarm service companies to respond to system malfunctions or maintenance issues in a time prescribed by the National Fire Alarm Code.
- The Fire Department must be notified of any system issues that render your fire alarm protection and detection system impaired for more than 8 hours; so that in the event of a fire, they are better prepared to protect life and property at your location until the alarm system functionality is fully restored.
- Provides confidence that your property, merchandise, customers, employees, and first responders have reliable code compliant protection in the event of a fire.
- A Certificated alarm system may qualify you for insurance discounts¹
