emission factors and preparing compliant reports can require an amount of time and resources that many businesses simply do not have.

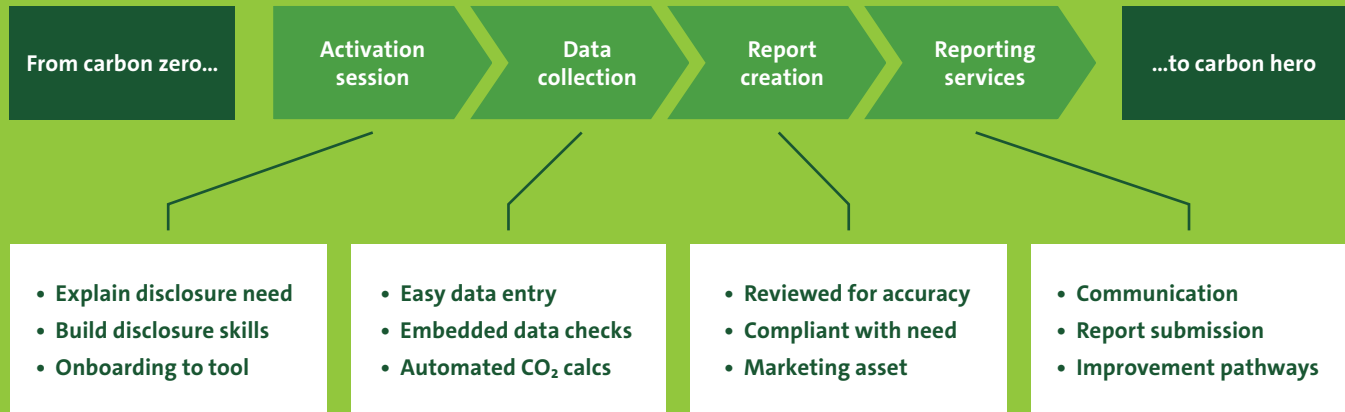
